## (Formerly PROTECTION AND ENVIRONMENT COMMITTEE)

This course is intended for officers and ratings holding (or will be holding) key duties and responsibilities concerning safety and environment committee work onboard ship in the role of safety representative, working environment committee member, committee representative, or ship safety officer.

### COURSE AIMS & OBJECTIVES:

- To gain knowledge of the applicable laws and regulations governing safety and environmental work onboard Norwegian vessels.
- To develop and enhance aptitude in recognizing work environment hazards and consequently implement appropriate preventive & safety measures and devise protection scheme.
- To practically utilize the knowledge and resources available in achieving the overall safety objectives of the Norwegian Maritime Directorate and the utmost protection of ships and shipping companies.

**COVERAGE / PROGRAM FOCUS:** The course deals with the legislative acts, regulations measures and on the following subject area:

- Seamen's Act (employment agreements; working conditions; workers' rights and obligations)
- Safety Regulations on Board Norwegian vessels
- Regulations concerning safety and environmental work onboard
- Work Environment Hazards
- Accident Prevention
- Inspection Procedures & Planned Maintenance
- Work Injuries and Preventive Measures
- Ergonomics / Enclosed Space
- Personal Protective and Safety Equipment
- Drugs and Alcohol Policy
- Pollution Prevention
- Accident Investigation & Reporting
- Safety Agenda and Reports

**METHOD:** Combination of lecture-presentation and discussions reinforced with case studies.

**ENTRY REQUIREMENT / TARGET GROUP:** Entry to this course is open to all officers and ratings with immediate function concerning safety and environment committee work onboard ship.
